FIRST THINGS FIRST

It has been my distinct pleasure to know Barney, 14018 and Molly Ziola, Friendship #1 since the early 80's, Barney was my Honourary NVP. Barney and Molly have been the back bone of the Canada JCI Senate since its inception and we owe them both such a sense of gratitude but its hard to put into words what 40's years of continuous devotion is and what it means. It does mean that the Canada JCI Senate has a future with a solid foundation moving forward. Here is a bio for Barney and Molly.

"I was transferred by the Canada Army Military, where I was stationed at Headquarters British Columbia Area in Vancouver, BC in the early period of 1952 until they decided to transfer me to the Military section of the Canadian Embassy in Washington, DC. Molly with a three-month-old baby girl and I were transferred in January 1958. We traveled by train from Vancouver to Minneapolis-Saint Paul - Chicago to the final leg of our journey to Washington, DC. We were met by a fellow Military Corporal who had been delegated to make a motel booking for us and to purchase a few supplies like eggs, bacon, milk, bread and a few other items to get us started. Then it was our responsibility to supply ourselves until we rented a home.

After about a week, we found a house to rent on 27 Street in Arlington, Virginia just a short distance across the Scot Key Bridge from Washington.

What a start to our young lives. Over the next few months we got to know the neighbors on both sides. Then one day Vance Workman a Gasoline Pump Attendant and Milton Brooks who owned a business leaned over our back fence and started to get to know us better and noticed by stating the fact we did not participate in any outside the home activities.

They both gave me a low down on what the Arlington Jaycees was all about with their activities that they were involved in during that current year. After all the information that I gained, I decided to join the group at the meeting being held at the Broyhill Auditorium. Well low and behold after receiving the authority to join the group from the proper Canadian member of the Ambassador/military, I was sworn in as a new Member of the US Junior Chamber of Commerce – Virginia - Arlington Chapter at their meeting in April 1958.

Well, the Arlington Jaycees are celebrating their 70th year of service to the Arlington community on September 22, 2018.

Molly and I agreed to join the Arlington Jaycee – 70th Anniversary for the main reason is that this is the same year that it is our 60th Anniversary. Myself as a Jaycee and Molly as a JCI Aid/Jaycette which the wives were called in Arlington and in Canada. I have always used the saying "If you are in our area – our home is your home."

Molly (86) and I (84+) after consideration and good sound medical advice have decided not to attend this very special event of our lives. I will be putting together and sending Senator Ariel Jones memorabilia (articles and pictures) of our special time with the Arlington Jaycees to see some of our time spent in their chapter and community.

I am very pleased and honoured to be the President of the Canada JCI Senate for another term. I have said many times that my Jaycee career was pivotal in shaping who I am as an individual and a citizen. Jaycees (JCI Canada) is the mother ship that my heart will always be linked to with the Senate being the yummy icing on an already amazing cake. The Senate at some point in the past shifted it's annual meeting to mostly the May long weekend but the May long weekend is a family time and the start of the camping season. I have clearly been told by the demographic that I believe is the future of the Senate, will not attend anything on the May long weekend. It is not a reflection on the relevance of the Senate, its just a generational reality. Additionally, many of the Senators of that demographic are attending the JCI Canada Regional and National Conventions. So, the Senate needs to meet where Senators are gathering.

I graduated high school in 1973 and there is no doubt that the world is very different than 1974, when the Senate began. Today Jaycees and many Senators live in a digital and social media world that seems to change daily. Email, Face Book and Snap Chat, Instagram, Twitter, have replace the land line phone and snail mail for communicating. Skype or other video services replace the need to meet face to face for a committee or executive meeting at times. I remember phone committees, which make me laugh at the inefficiency of that over the speed of information today.

This is the world today, the Senate needs to embrace all that has changed since 1974. I will put forward the notion that our annual meeting may not be called a "Crew Meeting" any longer or have a nautical theme. I am ready for an entire reboot or refresh.

My JCI Journey began a few years before I actually joined the organization in 2011, before I joined I had become friends with a few members that always thought I would be a great member... it took them a whopping 2 years to convince me of this. Before officially joining I would attend JCI socials and help out at JCI events and participate in them as well; But once I attended my 1st meeting January of 2011 I was hooked. My 1st year as a member I was helped with a large event the JCI Kootenay Chapter put on and in Oct of that year I put my name in to the running to be on the 2012 executive, I became the Social Director

Being Social director was really fun, but as someone that was naturally social it didn't really put me outside my comfort zone as so many Jaycees like to tell you is the best place to grow from. With some great mentorship and encouragement, I ran to be the 2013 Membership director, now this position was not a super stretch for a social person either, but it did teach me a lot about approaching people with very different personalities then mine and I felt the most connected to each member that year on a very personal level. I should mention that throughout these 3 years of being an official member, I never missed one meeting, or social and I volunteered to help with every event JCI Kootenay put on, I also attended regional and national conventions that solidified my connection with JCI. After my 2013 year I was honored to receive JCI Kootenay's Member of the year award. Receiving this award didn't slow me down, it made me want to give back even more.

In 2014 I wanted to take on a very large project so I stepped away from the executive for a year and chaired our Chapters largest money-making event of that year, this type of role teaches you more about leadership, organization and team building than I ever thought possible. After this event was over I changed my focus on doing something that gave back to our community, so I started a legacy project that would raise money so that we could build a Christmas float for our community. 2015 was the best and most difficult year as a JCI member for myself, Here I was Chapter president and in the middle of building a legacy project, when out of nowhere our largest Event (Balls of Steele) was losing interest with the Chapter and we had no one willing to take on the event, we had already committed to running this event for the community and for our budget so it needed to be run. I did what any great leader before me would have done and took on the event. Needless to say, this was a whirlwind of a year but one that taught me that you can't plan for everything, to always be prepared for something unexpected, to surround yourself with a good team, and most importantly to ask for help when you need it. PS the Event was a huge success, and we finished our Santa Float in time for the 2015 Parade.

In 2016 as past president I focused on helping the Chapter reorganize our priorities with events so that we could continue to run a successful Chapter as well as help coach the executive as best I could, and I guess they thought I did a pretty good job at it as our Chapter president nominated me as Regional and National executive member of the year where I was surprisingly awarded with both.

Most recently I started a campaign I hope to be an annual local campaign and possible a regional or national campaign called the Red Spot Campaign, where we raise money and awareness around the lack of feminine hygiene products in schools for young women due to poverty, home lives, and more. This is one of the things I am most proud of that I have achieved not only in JCI but because of JCI.

I was Awarded with my JCI Senatorship at this past BC Yukon Regional convention, just 8 years after my JCI Journey began but this is not where my JCI Story ends, stay tuned for the sequel!
