Secretary Treasurer Report June. 2019

Included are the Canada JCI Senate Financial Reports for the Senate fiscal year ending March 31, 2019. The financials have been reviewed by Senator Patty Auger 65436 and her report is included.

My Comments on Senate Fiscal Year ending March 31, 2019

- 1. Senate financial contributions about \$4,000 above budget. This was the result of many Senators adding extra to their normal annual contribution to help cover the shortfall from the previous year. Thank you Senators.
- 2. 126 Senators contributed in fiscal year ending March 31, 2019. In comparison 183 Senators contributed in fiscal year ending March 31, 2017.
- 3. On the expense side (Disbursements) we were very close on our totals to budget. However some expenses are over budget and need an explanation:
 - -Ambassador expenses included 2 years
 - Newsletters were sent via Canada Post to about 120 senators in the early part of the year. Senators have voluntarily reduced that quantity to 13.
 - Secretary Treasurer Expense of \$410. Error in budget expenses. Expenses incurred at beginning of fiscal year by mailing out paper copies of AGM reports to 12 senators .
 - Digital Costs of Survey Monkey for absentee voting not included in the budget

My Comments on Senate Budget for 2019-2020.

- 1. I have used a rough average of contributions for years ending Mar 31, 2019 and 2018.
- 2. Newsletter costs are down as we are sending out less paper copies
- 3. Secretary Treasurer Costs are down due to less paper reporting.
- 4. Executive Travel Costs are down as Senate AGM is held during Canada JCI Convention.

I was introduced to Jaycees in Victoria in 1964 and that was the beginning of a new Life Journey. I participated in many training programs and the one that had the greatest impact on me was Effective Speaking. I got involved in many projects, both as a committee member and chairman (The Jaycee Fair, Paint-Up Clean-up campaigns, Santa Ship etc). I made many new friends, learned the value of teamwork, the importance of being involved in one's community and began developing my leadership skills. I ran for executive positions, won some and lost others (a great learning experience). I attended District and Provincial Conventions, meeting more wonderful people who were also taking advantage of the Jaycee opportunity.

In 1970 I was transferred to Prince George and joined the Prince George Unit. Back then PG was a young, growing community (average age 32) and we were very involved through our projects. (Good Neighbor Week, Get out the Vote Campaigns, Our famous Baron of Beef Food Trailer, Mr. PG Book fund raising etc) I was fortunate to be one of the Presidents during the time we achieved "Blue Chip Unit" status (National Program) for 5 consecutive years and we were recognized as a "Gold Chip Unit". Prince George presented me with my Senatorship at the 1974 Regional Convention.

In 1974 I was transferred to Vancouver and joined the Guildford Jaycees. As I had already held positions at the local level, attended many Regional Training Seminars, several District, Regional (Provincial) and National Conventions, I decided to spread my wings and broaden my Jaycee experience at the Regional and National Levels.

I was fortunate to serve as Executive Director and National Vice President of the Pacific Region, then as National Executive Vice President and was elected as National President in 1978-79. My year as National President was an amazing experience. Meeting and interacting with fellow Jaycees from across Canada and around the world gave me a deep appreciation of cultural differences and a realization that those differences are what made us strong with the ability to make a difference in the world.

In my twilight years of Jaycee activity, I had the honor serving as Honorary NVP during Dan Toews year as Pacific Region NVP.

There were so many highlights and learning opportunities during my 20+ years of active involvement it is impossible to share them all. Through Jaycees I have made many friends and met many people who have made significant contributions to my life long journey and learning (it continues today). I uphold the Jaycee Creed as the basis of my personal values. This experience would never have been possible without the support and encouragement of my family, the members of the Units I belonged to and the countless friends I have made along the way.

I believe that Jaycees (or JCl as it is now referred to) has a significant role to play in the future of our communities and beyond through continued development of leadership skills, community involvement and a healthy dose of fellowship.

Overview of the review steps performed

- Prepared bank reconciliation for March 2019 and all bank statements for the year. The prior year unreconciled carry forward balance of \$25.49 has been adjusted for in the current year, with no carryforward balance remaining.
- Reviewed cash ledger maintained in excel. Based on descriptions of payments and deposits, amounts appear to be properly coded. No review of associated invoices, receipts or deposit books was completed.
- Converted cash ledger to an accrual basis including comparative figures in the financial statements.
- Prepared financial statements including comparative figures, prior year approved budget (18/19) and proposed budget for 2019/20.

These amendments to the Terms of Reference (TOR) are proposed for the Annual General Meeting on September 14, 2019. A vote will be held by an on-line vote prior to that meeting and by Senators present at the Annual General Meeting. Additionally, during the on-line vote and at the Annual General Meeting the executive will be asking for the authority to perform a complete review of the TOR with the goal to deleting redundancies and out of date policies along with proposals to bring the TOR in line with current practices.

- 5 6: Sixty (60) days prior to the Annual Meeting, the Nominating Committee will submit in writing to the Secretary Treasurer, the names of the Candidates for election. The Secretary Treasurer shall publish these names in the pre-convention issue of the Senate Newsletter.

The deadline for the receipt of nominations shall be such as to enable the names of those nominated to be included in the pre-convention issue of the Senate Newsletter
- 5-8: Delete
- 5-12: Election of elected members of the Executive shall take place at the Annual General Meeting/ The terms of elected members of the Executive shall commence at the close of the Annual General Meeting at which they are elected and terminate at the close of the next Annual Meeting. No elected member of the Executive may serve more than one consecutive year in any one office.

- 6.9 The executive shall administrate the annual balanced budget as approved by the Canada JCI Senate membership.
- 6.10 The executive shall issue a year to date financial budget report and financial asset statement at the end of each quarter to the Canada JCI Senate membership.
- 6.11 All Term Deposits/GIC's, unless previously earmarked must be reinvested at their book value. Interest earned will go into the Canada JCI Senate current account. Ten (10%) of the total book value of all Term Deposits/GIC's may be withdrawn annually for a very specific purpose as approved by the Canada JCI Senate membership.
- 8-23: All members of the Canada JCI Senate who are in attendance at the Annual General Meeting shall be entitled to vote on all of the agenda items. Alternatively, any member of the Canada JCI Senate shall be entitled to vote through the Absentee ballot system on changes to the Terms of Reference; the approval of the financial statements, the election of officers; the selection of the next Meeting of the Crew; and such other matters as the Canada JCI Senate Executive shall deem appropriate.
- 8-23: All members of the Canada JCI Senate who are in attendance at the Annual General Meeting shall be entitled to vote on all of the agenda items. Alternatively, any member of the Canada JCI Senate shall be entitled to vote through the absentee ballot system on changes to the Terms of Reference; the approval of the financial statements, the election of officers; the selection of the next Annual General Meeting. Items put for a vote at the Annual General Meeting must be circulated thirty (30) days in advance by electronic means. New items of business not circulated thirty (30) days in advance or amendments to circulated items may be made from the floor at the Annual General Meeting as recommendations for ratification by the membership. Those new items or amendments will not come into force until ratified by a vote of the membership by way of electronic means
- 10-1: Sixty (6) days notice is required of any proposed amendments to these policies. Notice shall be give by publication in the Canada JCI Senate/Senat JCI du Canada Newsletter.
- 10-1: Proposed amendments to these policies will be submitted to the executive forty-five (45) days in advance and the notice of the amendments to the membership will be given thirty (30) days in advance of the Annual General Meeting
