MEMORIAL - MAY THEY REST IN PEACE





NORMAN D "BUD" MCLAREN, SENATOR 26494 - JULY 2022

McLAREN, Norman D. "Bud" November 14, 1937 - July 28, 2022

A man's man in an era where such things are no longer celebrated: secure, confident, hardworking, non-complaining, self-sufficient, polite, kind and decent.

Born the 6th child of Dick and Marion McLaren, Norm, or Buddy as he was known to friends and family, spent his early childhood in North Vancouver. His father was 3rd Mate on the North Vancouver ferry, while his mother owned the Blue and Gold Cafe.

In 1946 the family moved to Victoria. Buddy excelled at all sports, especially soccer. According to Denny Boyd's October 19, 1951 piece, when the youth league was full, his mother Marion stepped up as the Founder, Manager, Coach and Trainer of the Mic Macs Soccer Club probably the only woman in Canada to do so. She was a force of nature. The team's unrivalled record of success and sportsmanship would set the mould for the man.

After graduating Victoria High School, Norm worked in Kitimat and Vernon. He was living in Vernon when he was drafted by the old Seattle Sounders, when they paid \$50 per game and \$25 per practice. While living in Seattle, he was drafted into the US Army. He trained at Ford Ord, California and was subsequently posted to the 5th General Dispensary, Robinson Barracks, Stuttgart, West Germany.

In 1963, in Germany, he married is fist wife, Heidi. A year later, Dan, was born. In 1964 the small family moved to Melbourne, Australia and in 1967 they moved to Victoria, BC. In Victoria, Norm began a career in finance. In 1971, Canadian Acceptance Corporation transferred Norm to Campbell River. Shortly thereafter he was recruited by Avco and then CIBC. Norm opened CIBC's Ironwood Mall branch and was subsequently recognized as one of the bank's top-10 managers in Canada, at Niagara Falls, Ontario.

In 1981 he bought the Ideal Grocery Store - which he owned for 5-years. In 1986 he became the (founding) Executive Director of Campbell River Tourism, a job he truly loved. He travelled the world promoting Campbell River.

In 1990 he married his best friend Jill and together they built a beautiful home at Saratoga

Beach, on the golf course. Later that year he accepted an offer to become the Executive Director of the Comox Valley Economic Development Society. He was a tireless advocate for the Comox Valley. He travelled around the globe seeking economic opportunities for his region. He was good at it.

In 2002 Norm retired from C.V.E.D.S. Apart from an occasional consulting contract he golfed, fished and spent time at the family cabin at Cluculz Lake, BC. On May 1, 2021 Norm celebrated his 8th hole-in-one. Not bad for an 83 year-old.

Norm's greatest joy flowed from family. Late in life Norm learned that had a son, Alan. Norm and Alan made up for lost time and quickly developed a loving relationship. Norm regretted not knowing Alan sooner.

Norm was the "go-to-guy" for his nieces and nephews. He was an anchor to his sons and a sounding board to his daughters-in-law. He was a de facto dad to many young men who lacked a father figure. He was the real deal.

Norm was a consummate volunteer. Past President of the Jaycees. 3-time President of the CR Chamber of Commerce. A qualified soccer referee. A Santa Claus to thousands of children (he even had a CRTV Christmas show). Past President of the Lacrosse Association. Emcee of countless Salmon Festivals, Oyster Eating Contests and Miss C.R. Pageants. In 1973, he organized the arrival of Campbell River's first cruise ship, the Fairsea. In 1975 he unsuccessfully ran for a seat in the BC Legislature. BC's loss.

Norm was recognized for his community work. In 1973 Campbell River recognized him as the Citizen of the Year. In 1978 Junior Chamber International awarded him a Senatorship, 26494. In 1981 he was Canada's Senator of the Year. In 1983 he was made a Fellow of the BC Chamber of Commerce. However his most cherished title was simply "Papa" - as he was affectionately known to his grandchildren.

Norm loved to watch Connor grow into a fine young man. He loved to fish with Sam. He loved to hear Sarah sing. He loved to hear Katie play the piano. Collect calls were always accepted. No matter was too small. Every recital was Carnegie Hall. Every hockey game was a Stanley Cup final. Every fish was "Walter".

Norm is pre-deceased by his father Richard "Dick" McLaren , mother Marion McLaren (nee McPhee), brother Donald McLaren, sisters Marva McLaren, Bonnie Tytler and Beatrice Forsythe.

He leaves behind: his beloved wife, Jill, sons Dan (Roberta), Loren (Mairi) Mallett and Alan Oakley. Brother, Richard McLaren. Grandchildren: Connor, Sam, Sarah and Katie. Numerous nieces and nephews. Friends too many to count. A grateful community and a legacy of service.

Norman Dennis McLaren leaves this world better than he found it. A man's man. We love you Papa.

Memorial service will be held Saturday, August 27, 2022, at Piercy's-Mount Washington, Courtenay, BC at 1:30PM. Wake to follow at Crown Isle Resort.
